ORDER:

1. **Dr. S. Thavamani**, Associate Professor in Botany, Directorate of Distance Education, S.V. University, Tirupati is promoted as **Professor with AGP ₹ 10000** in the pay band of ₹ **37400-67000** consequent on satisfying API based PBAS methodology laid down by UGC and assessment by a duly constituted Selection Committee under Career Advancement Scheme with effect from **07.03.2012** as approved by the Executive Council in its resolution fifth read above and subject to the decision on the SLP filed by the State Govt. in Supreme Court of India vide "pending SLP Registry Diary No.225637".
2. The promotion as Professor is subject to rules and regulations etc., formulated by the U.G.C. / A.P. State Government Rules / Laws of the University applicable from time to time.
3. The teacher is informed to convey her acceptance of promotion as Professor under Career Advancement Scheme on or before **18.01.2013**. If no acceptance is received before the stipulated date, these orders stand cancelled.
4. She shall execute an Agreement of Service with the University in the prescribed form on a non-judicial stamp paper worth of ₹ 100/- within a month from the date of issue of this proceedings to the undersigned.
5. Orders fixing the pay of the incumbent in the A.P. Revised UGC Scales of Pay, 2006 with effect from **07.03.2012** will be issued separately. However, she is permitted to draw the existing Pay and allowances till her Pay is revised. The promotion as Professor under C.A.S. now extended to the incumbent is notional with effect from the date of eligibility and the monetary benefit shall be extended to her from the date of her acceptance as Professor.
